#### **SECTION 1-MESSAGE TO PROGRAM PARTICIPANTS**

#### 1.1 Data submission deadlines

#### **Data submission deadlines**

State UCR Program managers should note the following deadlines for data to be received by the Crime Statistics Management Unit's (CSMU's) Operations Group and inform their local agencies of these deadlines.

Date	Information needed
August 23, 2013	Deadline to submit January through June 2013 data to the FBI for inclusion in the <i>Preliminary Semiannual Uniform Crime Report</i> , <i>January–June</i> , 2013.
<b>December 13, 2013</b>	Deadline to submit police employee counts as of October 31, 2013.
<b>December 31, 2013</b>	Deadline to change an agency's name or address, to add new contributing agencies within the state, or to change an agency's current reporting status.

### 1.2 Work processes for UCR publications

Preliminary Annual Uniform Crime Report, January-December, 2012 Crime in the United States (CIUS), 2012 Law Enforcement Officers Killed and Assaulted (LEOKA), 2012 Hate Crime Statistics, 2012 Preliminary Semiannual Uniform Crime Report, January-June, 2013

As part of the FBI's effort to keep state UCR Programs informed about data submission deadlines and UCR publication processes, we have included the following schedule. In order for the FBI to publish these Uniform Crime Reports on time with complete and accurate statistics, all states must adhere to the scheduled deadlines.

Most agencies are conscientious about meeting these deadlines; however, agencies that are late with their submissions cause delays to the publication process. The FBI realizes that there are extenuating circumstances that cause an agency to miss a deadline. Nevertheless, the FBI requests that state UCR Program managers encourage the agencies within their state to make every effort to adhere to these deadlines.

	❖ Requesting the verification of any January–December 2012 crime totals that indicate significant increases or decreases over the previous year's data and/or verification of any high or low monthly offense count(s) during the 12-month period for all contributors other than Most In Population (MIP) agencies.			
	❖ Informing them of the 2012 population estimates for agencies within their states.			
	Note: CIUS, 2012—For agencies to be included in Tables 8-11, the CSMU's Operations Group must receive 12 months of complete data.			
	LEOKA, 2012—Officer assault statistics include those law enforcem agencies that submitted both 12 months of officer assault data and police employee counts.			
	Hate Crime Statistics, 2012—Tables 13 and 14 of the publication will include the number of quarters in which an agency reported hate crime data.			
April	The CSMU's Operations Group disseminates letters to state UCR Program managers providing January–December 2012 crime totals/Return A Record Cards for all law enforcement agencies that submitted 12 months of complete data.			
May-June	The FBI releases the Preliminary Annual Uniform Crime Report, January–December, 2012.			
May-July	Staff from the CSMU and the Multimedia Productions Group (MPG) reviews and finalizes <i>CIUS</i> , <i>LEOKA</i> , and <i>Hate Crime Statistics</i> for publication.			
	The CSMU's Operations Group disseminates letters to state UCR Program managers providing their states' 2012 violent crime and property crime counts that will be published in <i>CIUS</i> and including the timetable for publishing 2013 UCR data.

July	The CSMU's Operations Group disseminates letters to state UCR Program managers requesting missing January–June 2013 data for MIP law enforcement agencies for inclusion in Table 4 of the <i>Preliminary Semiannual Uniform Crime Report, January–June, 2013.</i> The letters provide the August 23, 2013, deadline for submitting data to be included in the <i>Semiannual Report.</i>			
	Letters will be sent to those state UCR Programs for which no 2013 data have been received informing them of the August deadline.			
	The deadline to submit January–June 2013 data to the national UCR Program for inclusion in the <i>Semiannual Report</i> is Friday, August 23, 2013.			
August and September	The MPG disseminates a UCR <i>State Program Bulletin</i> to all state UCR Program managers providing the August deadline for submitting data for all law enforcement agencies for inclusion in the <i>Semiannual Report</i> .			
	The CSMU's Operations Group disseminates letters to all state UCR Program managers requesting verification of any January–June 2013 crime totals that indicate significant increases or decreases over the previous years' data and/or verification of any high or low monthly offense count(s) during the 6-month period for MIP agencies.			
	The deadline to submit January–June 2013 data to the national UCR Prog for inclusion in the <i>Semiannual Report</i> is Friday, August 23, 2013.			
September	The CSMU's Operations Group disseminates letters to state UCR Program managers:			
	❖ Identifying any missing January–June 2013 data that the FBI has not received by the submission deadline for the <i>Preliminary Semiannual Uniform Crime Report</i> to all contributors other than MIP agencies.			
	<ul> <li>Seeking follow-up for MIP agencies that did not respond to trend letters. (The Operations Group may opt to contact these agencies via telephone.)</li> </ul>			
	Requesting the verification of any January–June 2013 crime totals that indicate significant increases or decreases over the previous year's data and/or verification of any high or low monthly offense count(s) during the 6-month period for all contributors other than MIP agencies that submitted 3 or more months of data.			
	The FBI releases CIUS, 2012.			

Date	Work process
October	The CSMU's Operations Group disseminates letters to state UCR Program managers:
	Requesting the verification of any January–June 2013 crime totals that indicate significant increases or decreases over the previous year's data and/or verification of any high or low monthly offense count(s) during the 6-month period for all contributors other than MIP agencies that submitted 3 or more months of data.
	Requesting the completion of the police employee counts as of October 31, 2013.
	The FBI releases <i>LEOKA</i> , 2012.
November	The CSMU's Operations Group disseminates letters to state UCR Program managers requesting a review of the Population-by-County dataset to verify the current reporting status of each agency and to identify any new agency contributors.
	The UCR program disseminates a UCR <i>State Program Bulletin</i> reminding all state UCR Program managers of the <b>December 13, 2013,</b> deadline for submitting police employee counts and the <b>December 31, 2013,</b> deadline to change an agency's name or address, to add new contributing agencies within the state, or to change an agency's current reporting status. (The CSMU's Operations Group will not assign an Originating Agency Identifier until an agency submits one <i>Return A</i> form.)
	The FBI releases Hate Crime Statistics, 2012.
December	The deadline to submit police employee counts is Friday, December 13, 2013.
	After the December 13, 2013, deadline, the CSMU's Operations Group will forward letters to state UCR Program managers informing them if the FBI has not received their police employee counts.
	The deadline to change an agency's name or address, to add new contributing agencies within the state, or to change an agency's current reporting status is December 31, 2013.
	The FBI releases the <i>Preliminary Semiannual Uniform Crime Report</i> , <i>January–June</i> , 2013.

All state Programs are encouraged to submit data by established deadlines to ensure that the data are thoroughly reviewed. If publication deadlines cannot be met, agencies should continue to forward data so that these data can be entered into the UCR master data files.

# 1.4 Hate Crime Data Collection Guidelines and Training Manual and National Incident-Based Reporting System User Manual available electronically

Two documents, the *Hate Crime Data Collection Guidelines and Training Manual* and the *National Incident-Based Reporting System (NIBRS) User Manual*, are now available electronically on the FBI's Internet site and on the Law Enforcement Online (LEO).

The Hate Crime Data Collection Guidelines and Training Manual is a merger of two earlier publications (the Hate Crime Data Collection Guidelines and the Training Guide for Hate Crime Data Collection).

The publication reflects changes due to the passage of the Matthew Shepard and James Byrd, Jr., Hate Crimes Prevention Act of 2009, which expanded the bias motivation definitions for hate crimes. The UCR Program included new and revised hate crime definitions and provided corresponding examples.

The NIBRS User Manual is the companion handbook to the NIBRS Technical Specification, which was released in April 2012. The two NIBRS publications replace the legacy NIBRS Volume 1: Data Collection Guidelines, Volume 2: Data Submission Specifications, Volume 4: Error Message Manual, and the UCR Handbook, NIBRS Edition, and include all addenda and revisions of previous NIBRS documents.

Both the *Hate Crime Data Collection Guidelines and Training Manual* and the *NIBRS User Manual* are available electronically on the FBI's web site at <www.fbi.gov/about-us/cjis/ucr> and on the UCR Special Interest Group (SIG) on the LEO at <www.leo.gov>.

#### SECTION 2—CLARIFICATION TO POLICY AND PROCEDURES

### 2.1 Reporting 2012 and 2013 UCR data

In 2013, the national UCR Program expanded the technical requirements in the Summary Reporting System (SRS), the NIBRS, and hate crime in several ways:

- ❖ to include a race code of P = Native Hawaiian or Other Pacific Islander
- \* to allow the reporting of more than one bias motivation per offense and
- to allow the reporting of the ethnicity of the offender.

However, if a state UCR Program submits both 2012 and 2013 crime data electronically on one submission and the 2013 data have been formatted to include the expanded collection, the national UCR Program will not be able to process the data because the two years of data (2012 and 2013) will have different record lengths.

If a state UCR Program has submitted both 2012 and 2013 crime data electronically on one submission and the 2013 data have been formatted to include any new collection initiatives, the FBI will temporarily omit the offender's ethnicity data and any multiple bias motivation codes. In addition, the FBI will change any records with a race code of P to a race code of A = Asian. This will make the record lengths the same for both years in order to allow processing the 2013 data in the legacy UCR system.

The national UCR Program will process the 2012 data and the adjusted 2013 data. The 2013 data with the expanded information will be held until it can be processed via the New UCR system.

If the state UCR Program has the capability, the FBI would prefer that only one year of data be included on a submission.

# 2.2 Reporting trace amounts of drugs in the National Incident-Based Reporting System

The staff of the CJIS Division's CTAP Unit has received several questions regarding the proper way to report trace amounts of drugs in the NIBRS.

The smallest amount of drug quantity (Data Element 21 [Estimated Drug Quantity]) should be reported as 00000000001 (there are 12 characters for the field). Because the decimal point is implied, agencies should not enter a decimal point into Data Element 21.

For example, police arrest an individual who is in possession of a marijuana pipe. Police field test the marijuana pipe and find a very small amount of marijuana residue. The incident should be reported as a UCR Offense Code 35B (Drug Equipment Violation) and a UCR Offense Code 35A (Drug Narcotic Offense). The agency should report the drug offense with E = Marijuana as the suspected drug type, 0000000000001 as the estimated drug quantity, and GM = Gram as the type of drug measurement.

# 2.3 Changes to the National Incident-Based Reporting System Technical Specification
