The Associated Press (10/04, reported that Attorney General Merrick Garland on Monday directed federal authorities to hold strategy sessions in the next 30 days with law enforcement to address the increasing threats targeting school board members, teachers, and other employees in the nation's public schools. According to FOX News (10/04 the move comes just four days after a leading organization representing the nation's school boards called on the Biden administration and federal law enforcement agencies to assist school boards, which the group said have seen an increase in violent threats in response to COVID-19 restrictions and critical race theory curriculum. Politico (10/04, noted that Garland directed the FBI to meet with federal, state, local, tribal, and territorial leaders in each federal judicial district to "facilitate the discussion of strategies for addressing threats." "The Department takes these incidents seriously and is committed to using its authority and resources to discourage these threats, identify them when they occur, and prosecute them when appropriate," Garland wrote. 

Attached are two documents proposing Department responses to continuing threats against election officials and workers and recent threats against school administrators and board members.

**Draft AG Memo to USAOs and SACs** – draft guidance to USAOs and SACs voicing concerns about increasing threats against election officials and workers and, separately, against school administrators and board members and instructing them to convene separate meetings for each type of threat with state/local law enforcement and other affected parties.

Components Affected: EOUSA, FBI, CRM

Draft School Board Threats Response Strategy – lays out several proposals for addressing a recent uptick in threats of violence against school board members, as recently highlighted in a letter to the President from the National School Boards Association. The letter form the NSBA is also attached for reference. Components Affected: EOUSA, FBI, CRM, CRT, NSD, and OJP

The timeline on these documents is short, but we want to provide awareness to your components and give potentially affected components the opportunity to voice views/red-flag concerns.

## **Potential Statutes for Threats Cases**

## 18 U.S.C. § 875(c) – Threatening Communications

Prohibits sending interstate communications threatening to kidnap or injure any person.

Elements:

- (1) Defendant knowingly sent a communication in interstate or foreign commerce (e.g. email, internet, text);
- (2) Containing a "true threat" to kidnap or injure the person of another; AND
- (3) Defendant intended the communication to be a threat, and knew it would be perceived as a threat. Must prove defendant had a subjective, specific intent to threaten.

# 18 U.S.C. § 876(b) and (c) – Mailing Threatening Communications

Prohibits *mailing* a threatening communication to kidnap or injure a person. Also prohibits mailing a threat with intent to extort money or another thing of value. Otherwise, similar to 875(c).

## 18 U.S.C. § 2261A(2) - Cyberstalking, but also covers mail and electronic communications

Prohibits using the mail or a facility of interstate commerce (e.g. internet, text, email, interstate phone call, and social media) with the intent to kill, injure, harass, or intimidate a person. Must show defendant engaged in a course of conduct that placed a person in reasonable fear of death of or serious bodily injury to that person, an immediate family member, or a spouse or intimate partner, or caused substantial emotional distress.

## Elements:

- (1) With the intent to harass or intimidate a person,
- (2) Defendant used the mail or an electronic communication service or electronic communication system of interstate commerce, or any other facility of interstate or foreign commerce, to engage in a course of conduct that *either*,

(3) placed a person in reasonable fear of death of or serious bodily injury to that person, an immediate family member, or a spouse or intimate partner, *OR* caused, attempted to cause, or would be reasonably expected to cause substantial emotional distress to that person, an immediate family member, or a spouse or intimate partner.


## 18 U.S.C. § 245 - Interfering with federally protected activities

Prohibits both use of force and *threats* of force because of race, religion, color, or national origin, *and* because the victim was enjoying a statutorily enumerated right.

## Elements (limited summary):

- (1) Defendant used force or threat of force
- (2) Defendant acted willfully
- (3) Defendant acted because of race, religion, color, or national origin, and also
- (4) Defendant acted *because* the victim was enjoying a specifically listed federal right:
  - Right to attend public school
  - Right to services provided or administered by any State or subdivision thereof (i.e. police?)
  - Right to use state facility or program
  - Right to employment
  - Right to serve in court
  - Right to use a facility of interstate transportation
  - Right to use a facility of public accommodation

## 18 U.S.C. § 1951 - Hobb's Act Extortion

## Elements:

- (1) Defendant obstructs, delays, or affects commerce or the movement of any article or commodity in commerce, by extortion; or
- (2) Defendant attempts or conspires to obstruct, delay, or affect commerce or the movement of any article or commodity in commerce, by extortion; or
- (3) Defendant commits or threatens physical violence to any person or property in furtherance of a plan or purpose to do anything in violation of this section.

## 18 U.S.C. § 1952

Defendant traveled in intestate or foreign commerce or used mail or facility of interstate or foreign commerce, with the intent to:

- (1) distribute the proceeds of unlawful activity; or
- (2) commit any crime of violence to further any unlawful activity; or
- (3) otherwise promote, manage, establish, or carry on any unlawful activity and thereafter distributes the proceeds of unlawful activity or commits violence in furtherance of unlawful activity

(c) [Whoever knowingly deposits in any post office or authorized depository for mail matter, to be sent or delivered by the Postal Service or knowingly causes to be delivered by the Postal Service according to the direction thereon], any communication with or without a name or designating mark subscribed thereto, addressed to any other person and containing any threat to kidnap any person or any threat to

injure the person of the addressee or of another, shall be fined under this title or imprisoned not more than five years, or both.

#### PENALTY: Five (5) year maximum



#### 18 U.S.C. § 245 [Threats in Relation to] Federally Protected Activities RELEVANT TEXT

....

(b)Whoever, whether or not acting under color of law, by force or threat of force willfully injures, intimidates or interferes with, or attempts to injure, intimidate or interfere with—

(1) any person because he is or has been, or in order to intimidate such person or any other person or class of persons from-

(E) participating in or enjoying the benefits of any program or activity receiving Federal financial assistance

.....

(2)any person because of his race, color, religion or national origin and because he is or has been-

enrolling in or attending any public school or public college;

...

(C) applying for or enjoying employment, or any perquisite thereof, by any private employer or any agency of any State or subdivision thereof, or joining or using the services or advantages of any labor organization, hiring hall, or employment agency

PENALTY: One (1) year maximum if no bodily injury and no use or threatened use of dangerous weapon or explosive

Ten (10) years maximum if bodily injury or use or threatened use of dangerous weapon or explosive

Life imprisonment or capital punishment if death results or kidnapping involved

#### 47 U.S.C. § 223 – Harassing Telephone Calls RELEVANT TEXT

... (a)Prohibited acts generally Whoever—

(1) in interstate or foreign communications-

...

(C)makes a telephone call or utilizes a telecommunications device, whether or not conversation or communication ensues, without disclosing his identity and with intent to abuse, threaten, or harass any specific person

#### PENALTY: Two (2) year maximum



#### 18 U.S.C. § 2261A – Cyberstalking RELEVANT TEXT

(2) [Whoever] with the intent to kill, injure, harass, intimidate, or place under surveillance with intent to kill, injure, harass, or intimidate another person, uses the mail, any interactive computer service or electronic communication system of interstate commerce, or any other facility of interstate or foreign commerce to engage in a course of conduct that—

(A)places that person in reasonable fear of the death of or serious bodily injury to a person, a pet, a service animal, an emotional support animal, or a horse described in clause (i), (ii), (iii), or (iv) of paragraph (1)(A); or

(B)causes, attempts to cause, or would be reasonably expected to cause substantial emotional distress to a person described in clause (i), (ii), or (iii) of paragraph (1)(A)

**PENALTY:** Five (5) year maximum if no injury results; Ten (10) to life if injury or death results, depending on type of injury (enhanced by additional five years if victim is a minor)

Boss-

The School Board (SB) Threat WG held a one-hour call this afternoon. It was largely an introductory and coordination call with no specific due outs for either CID nor CTD. The near term goal is for a memorandum to be drafted and approved by all parties for distribution to USAOs with guidance to include opportunities to train local school boards. The training piece is being spearheaded by DOJ's Office of Justice Programs who will receive feedback from CTD & CID prior to initiation.

CTD reiterated that we can track any future SB threat through NTOC and use of a specific Guardian tag. Depending on ideology, either CID or CTD will program manage the Guardian and potential FI should it progress.

Next call is tentatively scheduled for Friday.
