Of these 2,781 identified persons, 36 percent were determined to be users of narcotics, and 27 percent were found to have been previously convicted in either federal or state court for bank robbery, bank burglary, or bank larceny.

These acts included 38 instances involving the discharge of firearms, 71 instances involving assaults, 3 instances involving explosives, and 21 instances involving a hostage taken. (One or more acts of violence may occur during an incident.) These acts of violence resulted in 31 injuries, 11 deaths, and 34 persons taken hostage.
