Background Information

The FBI Washington Future Agents in Training will take place July 14 - 18, 2025 . The program is open to high school students between the ages of 16 - 18 (Must be 16 by the first day of the program). Punctuality, professional behavior, and appropriate dress will be required of all students participating in this program.

Our Future Agents in Training program allows students an opportunity to get a comprehensive look into today's FBI. Generally, each course iteration is a minimum of eight hours but can be a week-long program with blocks of instruction and demonstrations at a local field office. Students are provided with several presentations on topics including terrorism, cybercrime, public corruption, polygraph exams, evidence response, SWAT, and the day-to-day operations of a typical FBI office. Students also learn from special agents, intelligence analysts, language specialists, and professional staff about investigative tactics that include gathering evidence, interviewing witnesses, and assisting with cases

A selection committee will evaluate each application based on a review of the information provided, and no single element is disqualifying. See our website at www.fbi.gov/contact-us/field-offices/washingtondc/community-outreach for more information on our selection criteria. If possible, we recommend that the student fill out the application electronically.

Whether typed or hand-written, illegible applications or applications scanned at a low quality will not be reviewed. Likewise, incomplete or late applications will not be accepted.
