- Student is currently enrolled in an accredited high school. If home schooled, the student is recognized by a school district. (Students graduating from an accredited high school in the spring of 2021 are still eligible to apply.) Student must be 16 to 18 years old as of 08/03/2021.
- Student has a Grade Point Average (GPA) of 3.0 or higher.
- Student completed the two required essays (see section VII).
- Student understands he/she must be present each day of the FAIT program that will be hosted via Microsoft Teams.
