

## SUSU

The Step Up, Speak Up (SUSU) Campaign began as a partnership between the Federal Bureau of Investigation (FBI) Philadelphia Division's Community Relations Unit, Mothers in Charge (MIC) and Clear Channel Outdoor in an effort to encourage citizens living in the Philadelphia area to cooperate with law enforcement.

Should you come forward if you have information you think that law enforcement should know? Do you have doubts about whether to report what you have seen?

*Step up and make a difference  
We need to speak up and be a witness  
Only way to stop this violence  
We're gonna have to break our code of silence  
Step up and make a change  
Speak up! Don't let them get away  
Crime and Murders on the rise  
We gotta stand and Testify  
Undertakers are getting rich

There is no legal obligation to contact the police or other law enforcement agencies, but the information you give them could make the difference in bringing a criminal to justice. Your cooperation could prevent further crimes and protect others from becoming victims. All crimes, even less serious crimes, have a negative effect on our neighborhoods. Help your community by reporting what you know.

It is a criminal offense to intimidate a witness or anyone assisting law enforcement in an investigation. Some forms of intimidation are community-wide and subtle, such as the "Stop Snitching" apparel and popular music and videos.

The SUSU campaign is a response to those subtle forms of intimidation. The following is a resource guide for those who are considering or willing to "take the big step."

### **To Provide Information Regarding a Violent Crime Investigation:**

**Federal Bureau of Investigation (FBI):** The Philadelphia FBI's Violent Crimes & Major Offenders Squad and Criminal Enterprise Squads investigate violent crimes to include, bank robberies, fugitives, Hobbs Act robberies, kidnappings, gang related drug cases, organized crime and domestic police cooperation cases. Anyone with information regarding an FBI investigation should call the FBI Philadelphia's 24 hour switchboard at (215) 418-4000.

**Philadelphia Police Department:** The mission of the Philadelphia Police Department is to work in a true partnership with our fellow citizens of Philadelphia to enhance the quality of life in our city and, by raising the level of public safety through law enforcement, to reduce the fear and incidence of crime. investigation, contact the Detective Division in the district where the crime occurred.
